

INDEMNITY BOND

(To be typed on non-judicial Stamp Paper of Rs. 100=00 and attested by Notary Public)

This Indemnity Bond is executed on this _____ day of _____, 20____ at KARACHI, by M/s _____, a company / firm having its registered / corporate office at _____ and a Liaison / Branch Office at _____ (Pakistan) /or legally appointed Agent in Pakistan, namely Mr./Ms. _____, having his/her/its office at _____, represented through Mr./Ms. _____, son/wife/daughter of Mr. _____, its duly authorized representative (hereinafter referred to as 'the Licensee'), in favour of Pakistan Standards and Quality control Authority of Pakistan Standards, having its head office at Block 77, Pakistan Secretariat Saddar Kaarchi-74400 (hereinafter referred to as 'PSQCA' or 'the Authority') :

WHEREAS the licensee who is engaged in the business of manufacture of _____ (name the product for which licence is being obtained) outside Pakistan, has approached the PSQCA for grant of PSQCA Certification Mark licence for use of the Pakistan Standard Mark on the aforesaid product, as conforming to Pakistan Standard _____;

AND WHEREAS as per the product certification of PSQCA under which the licence is granted to the Licensee, the PSQCA on being satisfied that the product manufactured by the licensee conforms to the particular Pakistan Standard, merely gives a licence to the licensee to use the Pakistan Standard Mark on such product as conforming to the Pakistan Standard;

AND WHEREAS the responsibility of conformance to the relevant Pakistan Standard with respect to the product in respect of which the licence is granted is the sole responsibility of the Licensee, and in case of non-conformance, the licence is liable to be deferred or cancelled by the PSQCA;

AND WHEREAS the Licensee has entered into an Agreement with the Authority in connection with the grant of the licence, wherein it is stipulated that the Licensee shall execute the present Indemnity Bond to hold the PSQCA indemnified and harmless against any third party claims in respect of non-conformity of the product manufactured by the Licensee on which the Pakistan Standard Mark is used by the Licensee;

NOW THEREFORE this Deed witnesses and it is agreed to and undertaken by the Licensee to safeguard the interests of the PSQCA and to keep them harmless against any claim or demand made or proceedings initiated by any one against the PSQCA in respect of nonconformity of the product manufactured by the Licensee on which the Pakistan Standard Mark is used by the Licensee, and indemnify the PSQCA in that regard including damages, interest or cost thereof.
